

**NOTES:**

- TEMPORARY HAYBALE/SILT FENCE EROSION CONTROL BARRIER SHALL BE MAINTAINED THROUGHOUT SITE CONSTRUCTION. STOCK PILE ON SITE 50 HAY BALES AND 100 FT. OF SILT FENCE FOR EMERGENCY USE. TEMPORARY EROSION BARRIERS SHALL REMAIN IN PLACE UNTIL PERMANENT VEGETATIVE GROUND COVER IS ESTABLISHED.
- TEMPORARY STILLING BASIN SHALL BE UTILIZED FOR ANY DE-WATERING DISCHARGE WHICH MAY OCCUR DURING CONSTRUCTION OPERATIONS. SEE DETAIL 3/S-2.
