ONGOING CONDITIONS

1. Split rail fence to be maintained in good condition by the property owner for perpetuity.
2. Structures are prohibited within 50 feet of the wetlands.
3. There shall be no alteration whatsoever behind the split rail fence. This is a protected wetland area.
4. There shall be no disturbance in the 25-foot wetland buffer strip.
5. This property is within 100 feet of wetlands and has certain restrictions placed upon it. Any improvements, structures, or alteration of land or vegetation may require the approval from the Conservation Commission. Please contact the Conservation Office prior to doing any work on the property.
