JANUARY 9, 2019

Chairman Andrade opened the meeting at 7 p.m. followed by the Pledge of Allegiance and moment of silence.

He announced that, in accordance with M.G.L. Chapter 30A, Section 20(f), any person recording the meeting must notify the Chairman. The Board of Selectmen is recording via audio and visual.

BOARD AND COMMITTEE OPENINGS UPDATE

Mr. Almeida announced that volunteers are needed on the Charter Study Committee (up to 6 Board of Selectmen appointments), Conservation Commission (3 BOS), Cultural Council (2 BOS), Energy Committee (1 BOS), Historical Commission (3 BOS), Property Tax Work-Off Committee (3 BOS), Recycling Committee (up to 4 BOS), Taxation Aid Fund Committee (1 BOS), 540 Arcade Avenue Phase II Building Committee (3 Moderator, 2 BOS), Veterans Council (5 BOS).

PRORITY MATTERS

Appoint and Swear In Lt. Allan Grocott to the Position of Deputy Fire Chief

Chief Michael Healy noted the Board had appointed Lt. Grocott at the last meeting. He is the first full time deputy chief in the history of the Seekonk Fire Department.

A motion was made by Mr. Viera, seconded by Ms. Hines, and it was unanimously

VOTED: To swear in Allan Grocott as Deputy Fire Chief with the Seekonk Fire Department.

Asst. Town Clerk Loraine Sorel swore him in. His wife, Susan, pinned the badge.

Appoint and Promote Firefighter Adam Dalessio to the Position of Fire Lieutenant

Chief Healy requested the appointment of Firefighter Adam Dalessio as Lieutenant. Mr. Cadime recommended as stated by the Chief.

Consider the Conditional Offer of Employment to Jesse Kingman as a Probationary Third Class Firefighter

Chief Healy requested the conditional offer of employment to Jesse Kingman as a Probationary Third Class Firefighter. Mr. Cadime recommended as stated by Chief Healy.

A motion was made by Mr. Viera, seconded by Ms. Hines, and it was unanimously

VOTED: To extend a conditional offer of employment to Jesse Kingman as a Probationary Third Class Firefighter.

Chief Healy publicly thanked the Board and previous board members. In the 4 ½ years he has been chief, this Board has supported every request.

Consider the Appointment of James Halpin to the Position of Truck Driver/Laborer for the Department of Public Works

DPW Supt. David Cabral recommended the appointment. Mr. Cadime concurred with the recommendation.

Mr. Viera commended the Save-A-Pet members for their hard work and assistance.

Vote to Allow the Town Administrator to Accept Gifts, Monetary and Tangible, Donated by Save-A-Pet Society to the Seekonk Animal Shelter during the Year 2019

A motion was made by Mr. Viera, seconded by Ms. Hines, and it was unanimously

VOTED: To authorize the Town Administrator to accept gifts, monetary and tangible, donated by Save-A-Pet Society to the Seekonk Animal Shelter during 2019.

Vote to Accept a \$300,000 Donation from the Save-A-Pet Society to the Town of Seekonk for the New Animal Shelter

Mrs. Cloutier presented the Board of Selectmen with a \$300,000 check for the new animal shelter.

A motion was made by Mr. Almeida, seconded by Mr. Viera, and it was unanimously

VOTED: To absolutely accept the \$300,000 donation from Save-A-Pet Society to the Town of Seekonk for the new animal shelter.

Mrs. Cloutier thanked Mr. Cadime for his help. She also thanked the Save-A-Pet volunteers and staff at the shelter. She noted that some of the volunteers have waited 30 years for this to happen. She also thanked donors and the residents who voted to keep this project going.

Mrs. Cloutier explained the Save-A-Pet Society is a non-profit organization that assists the animal shelter through various fund raisers.

She noted the auction this year will be totally different. It will be on Friday, April 26, 2019, at the Ramada Inn.

Animal Control Officer Sharon Hall thanked Save-A-Pet members who raise money but also help out at the center.

Consider the Approval of the Contract for Architectural Services for Aitken School to include OPM Services

Chairman Andrade stated this was an oversight brought to his attention last night. It falls under the 48 hour rule.

Mr. David Saad, 154 Forsythe Circle, a member of the Aitken School Building Committee felt the RFP should have been sent out by that committee.

Chairman Andrade said it was presented at Town Meeting that the RFP went out and bids had come in. That is what delineated the dollar amount voted at Town Meeting.

Mr. Saad said the warrant article didn't state that. He questioned what the building committee will do.

Mr. Cadime said the building committee will approve the design and also review all invoices.

Chairman Andrade felt the School Committee needed to move forward because students are in temporary trailers.

Ms. Hines said it doesn't negate the building committee because it says design plans and specifications. The building committee has an architect to work with.

School Committee Chairwoman Kim Sluter clarified the process. This has been going on for several years. Multiple options were discussed at the Quad Board meeting on October 3, 2018.

VOTED: To award the contract to DRA Architects for designer services in the amount of \$498,500.

VOTED: To award the contract to Compass Management Group for Owners Project Management (OPM) in the amount of \$140,866

Mrs. Sluter thanked Board members. She is pleased to have Mr. Zorra as the Board's representative on the building committee.

Mr. Cadime said the petition submitted by Mr. Tapalian has 200 signatures and according to the Atty. General's office, all signatures are considered petitioners.

Ms. Hines felt they signed to allow the petitioner to submit the petition.

Mr. Zorra would like to see more involvement with social media.

Mr. Cadime said the new website has been getting a lot of hits. Will continue to do those kind of things.

Mr. Zorra suggested that department minutes should be updated on the website.

He asked why Verizon is installing wires in the south end.

Ms. Hines announced the Taste of the Town is scheduled for March 5, 2019 at the Clarion Hotel. Tickets are \$30.

Mr. Almeida had residents asked about dogs not being banned in public. That is not happening.

He commended the new Superintendent of Schools and the School Committee on moving Dr. Whalen to the high school and Ms. Boucher to principal of the middle school.

Mr. Viera had a request from a Leonard Street resident to repair potholes.

He talked about assisting residents living in trailers because their homes were damaged by fire.

Chairman Andrade forwarded an e-mail to Mr. Cadime regarding branches, trees and telephone lines on West Avenue.

Mr. Cadime said the next agenda will include the make-up of the 540 Arcade Avenue Building Committee. There will be a meeting with the Planning Board regarding Jacoby Way. Counsel will be in attendance.

Mr. Cadime will schedule discussion on marijuana with the attorney at a future meeting.

In response to Ms. Hines question, Mr. Cadime he will interview applicants for the Veterans Council and made recommendations to the Board.

Mr. Viera noted any residents can apply; it does not have to be a veteran.
