NOVEMBER 13, 2019
REGULAR SESSION

LICENSE HEARINGS

Consider the Request for a Change of Manager of an Annual On-Premise All Alcohol Beverage Liquor License for Plaza Azteca Seekonk, Inc., d/b/a Rebeco Mexican Bar and Grill, 353 Highland Avenue, Seekonk, MA, Reina Valerio to be Manager

Atty. John Kennelly was in attendance to represent the applicant. He understood that all requirements for change of manager have been met.

He expressed his appreciation to employees in the Town Administrator's office for their hard work and patience.

In response to Mr. Viera's questions, Atty. Kennelly advised the license was surrendered between 11 and 11:15 a.m. the morning after the last meeting and all alcohol was removed from the premises by distributorers pursuant to state law.

OLD BUSINESS

Discussion of Independent Engineer's Letter Regarding Donald Lewis Drive

DPW Superintendent David Cabral read a letter from Robert Patneauade, P.E. and James Noyes of Greenman-Pedersen, Inc. regarding a review of Colfall Street, Massasoit Drive, and Donald Lewis Drive. The opinion of GPI is that the application of double chip seal pavement on low volume roads is the best economical treatment that can be considered to extend the life of the pavements. In addition, the application and workmanship of the double chip seal pavement on the streets treated both this year and in past years is more than satisfactory. Vehicles driving over the pavement will "polish" the stone, as well as work the stone into the asphalt emulsion. DPW has removed loose stone, and will repeat in the spring.

Mr. Viera said it is difficult to compare Donald Lewis Drive with Cole Street because of the traffic.

Mr. Sullivan agreed. He said they used rubberized chip seal on Cole Street.

Mr. Cabral said the comparison was not made to Cole Street. The conversation at the previous meeting was if they used the single rubberized chip seal on Donald Lewis Drive it would look similar to Cole Street.
