The meeting was held via Zoom.

#### **Accept the Resignation of Krystal Dos Santos as Senior Secretary for the Planning Board and Zoning Board of Appeals**

Mr. Cadime advised he spoke to Ms. Dos Santos. She has accepted a position that will be better for her career. She has been an integral part of that office and town hall. She will be missed. He recommended to accept the resignation with regret.

A motion as made by Mr. Andrade, seconded by Mr. Petronio, and it was unanimously

#### **Consider the Request for Street Acceptance of Palmer River Road and Forward to the Planning Board for a Recommendation**

Mr. Andrade made a motion, Mr. Petronio seconded, and it was unanimously

Mr. Cadime said that will be reviewed prior to making a recommendation. There have been issues. It might constitute coming back to the Board of Selectmen.

Mr. Rick Bessette of Madeira Ventures called in and offered to answer questions.

Mr. Healy suggested the Board wait until the Planning Board review. There are several Conservation issues with that road.

Mr. Bessette said he has been talking to Mr. Aubin. Items on the punch list were completed. He thought the next step was to go to the Planning Board.

Town Planner John Aubin III advised that GPI Engineering provided a punch list to Mr. Bessette. He is waiting for a report from GPI. That will be noted in the Planning Board report back to the Board of Selectmen.

**Discussion with the Seekonk Connolly Field Turf & Renovation Building Committee Regarding Proposed Project**

Dr. Rich Drolet, Superintendent. of Schools, stated the Finance Committee approved a warrant article in the fall 2019 and the Board of Selectmen recommended approval of the design phase. This is important for the students and also the entire town.

Mr. Chris Huntress of Huntress Sports made a presentation to the Finance Committee and is now before the Board of Select men.

The building committee is working very hard to move this forward. The tennis and basketball courts were recently improved. A turf field is extremely safe.

Mr. Huntress and Turf Field Building Committee Chairman Steve Prew were in attendance.

The proposal will include a new synthetic turf field, new 400 millimeter running track, field event improvements, sound system, LED sports light, new storage shed, press box, improved walkway fences and gates and improved drainage. All are ADA and Title 9 approved.

Mr. Zorra read a statement taken from the November Town Meeting. There was scrutiny over this building committee. He noted this building committee was tasked with improving the entire complex.

Mr. Healy said the presentation made at that Town Meeting was vague. It is supposed to be just a turf field. It was misleading to the people who voted at Town Meeting.

Mr. Andrade said this is the first time he is seeing this presentation.

Mr. Petronio said it is good that it is a multi-use field.

Mr. Prew said the committee met with coaches in order to get input. He said Mr. Pozzi was not consulted.

Mr. Huntress explained the maintenance cost is \$7,500 per year. He recommended an independent third-party testing firm. The field has a ten-year warranty. There is a chalk pad which protects against concussions.. It has a 25-year warranty.

In response to Mr. Andrade's question, Mr. Huntress had a cost estimate he shared with the Finance Committee.

Mr. Cadime questioned when the carpet needs to be replaced. He asked about lighting.

Mr. Huntress said the cost to replace carpeting is \$450,000. Five LED lights will go on the poles and foundation in place now.

Dr. Drolet said the project could have been over \$4M. The building committee decided against the bleachers and lighting poles to keep the cost under \$3M. He said the School Department would be willing to contribute when it is time to replace the turf in 10 to 15 years from now.

In response to Chairman Sullivan's question, Mr. Huntress said there is a lot of value doing the turf field and the track together. When they evaluated the existing track, it is 20 years old and asphalt is shrinking and cracking. There is a tremendous amount of savings in doing it all together.

Mr. Petronio asked if the \$450,000 replacement in fifteen years is in today's dollars.

Dr. Drolet said the plan is to rent out the field. He said, if approved, it could be done within a year.

Mr. Andrade said he is a proponent of the project but there are a lot of issues. The Board should have seen the presentation sooner.

Chairman Sullivan is it is possible to make a recommendation on Town Meeting floor.

Mr. Cadime said this field is not involved with Parks & Recreation. It will be controlled by the School Department and School Committee.

Mr. Zorra noted people sitting in the lower stands cannot see over people who stand there.

Mr. Huntress said they are trying to be cost effective.

Mr. Zorra agreed that the fields should be rented when not in use by schools.

Chairman Sullivan requested that the presentation and cost estimate be forwarded to the Board for review.

He thanked the Turf Field Building Committee and Huntress Sports for the work they have done.

Mr. Andrade echoed those words. He doesn't want his comments to be perceived as questioning the Committee. He wants more information.

Dr. Drolet noted that the high school football team does not practice on the field and the soccer team plays elsewhere.
