Rather, this article is simply intended to provide a basic understanding of why estate planning is important for everybody and a basic understanding of some of the more common estate planning tools. This article does not constitute legal advice.

The New Massachusetts Homestead Exemption Law Change: What Homeowners Need to Know

In a significant development for Massachusetts homeowners, the Affordable Homes Act recently passed on August 6, 2024 has enhanced protections for primary residences. The Homestead Exemption is a crucial legal provision that shields the equity in a person's home from creditors in the event of bankruptcy, debt collection, or lawsuits.

What Is the Homestead Exemption? The Homestead Exemption is a legal safeguard that protects the equity in a primary residence from certain creditors. This protection applies to single-family homes, condominiums, and some multi-family homes, as long as the property serves as the homeowner's principal residence. While it does not shield homes from all forms of debt—such as mortgages, tax liens, MassHealth estate recovery liens, or child support—it can be a powerful tool for protecting a family's most valuable asset.

In Massachusetts, homeowners are automatically protected up to a certain amount of equity, even if they don't file for the Homestead Exemption. For those who file a declaration of homestead with the Registry of Deeds, the protection amount is higher.

Key Changes Under the New Law: **1. Increased Protection Amounts:** The automatic exemption for homeowners is \$125,000. However, if a homeowner files a declaration of homestead, the protection amount increases to \$1 million which is a substantial increase. **2. Enhanced Protections for the Elderly and Disabled:** Homeowners who are elderly (62 years or older) or disabled are also able to stack their exemptions which could mean up to \$2 million in protection. **3. Trusts:** A primary residence held in a trust can also qualify for a homestead exemption.

Protection for Proceeds from Home Sale: If homeowners sell their property, the proceeds from the sale are protected for up to one year under the Homestead Exemption. This offers an additional layer of security for those who need time to reinvest their home equity into a new property. This ensures that sellers aren't vulnerable during the home-buying transition.

How Does This Affect Homeowners? The changes to the Massachusetts Homestead Exemption law provide a greater level of security for homeowners. By increasing the exemption amounts, the new law lines up with the increasing housing market and ensures that individuals and families have a stronger safeguard against unexpected financial burdens.

For those concerned about protecting their primary residence from creditor claims, it's a good idea to file a Declaration of Homestead with the Registry of Deeds, particularly in light of the enhanced protections.

For elderly homeowners or those with special circumstances, it may be wise to consult with an estate planning attorney to ensure your home is protected under the new law.

Telephone Reassurance Program

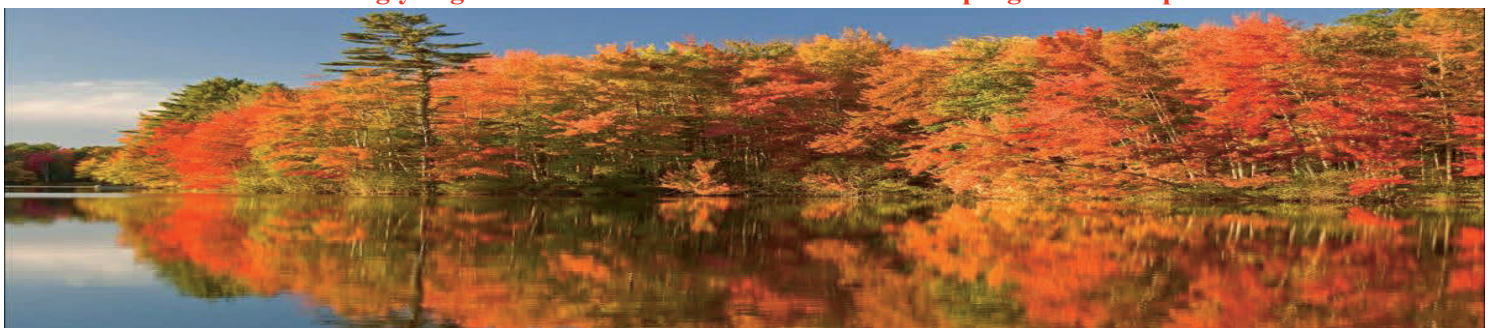

This program is designed for senior citizens, disabled persons and shut-ins living in Seekonk who may be at risk of loneliness, social isolation, illness or injury. 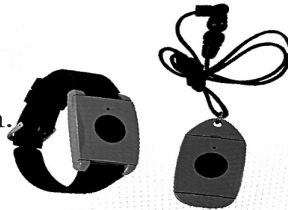

Medicare Open Enrollment

During Medicare Open Enrollment, you can adjust your plan for the next year. Independent Medicare counselors help you understand *your* plan changes as well as *other options* you may have. Open Enrollment is open **now through December 7!**

***Please note all clients will be required to fill out a Medicare prescreening form to help us better serve you by looking up your current plan and comparing it to the future plans, if changes are necessary.**

Fuel Assistance

Income guidelines: Maximum income for one person is \$49,196, for two people is \$64,333, for three people is \$79,470, and for four people is \$94,608. Returning applicants must provide proof of income (pension, interest, dividends, 401K/IRA distribution). New applications must provide income, mortgage or rent bill, real estate taxes, homeowners insurance, utility bills (electric, gas and/or oil), social security card, government photo ID, and birth certificates for those under the age of 18.

Fuel assistance begins November 1st. For assistance please call our office to schedule an appointment with our outreach worker. Applications are accepted until April 30, 2025.
